### **Resolution 2023-10**

Within Resolution 2023-10, there are 3 separate items regarding chapter 3 (Thoroughbred wagering) and chapter 13 (Standardbred wagering):

Chapters 3 and 13 were mostly identical, except where chapter 3 refers to Stewards, and where chapter 13 refers to Judges.

1. Within Chapter 3 (thoroughbred wagering) there are “no-change” rules to be filed that were identical in chapters 3 and 13.
2. Within Chapter 3 (thoroughbred wagering) there are amended rules to be filed that now encompass both breeds (ie: “steward or judge” instead of “steward”) and remove many of the words SB 9 considers to be “regulatory restrictions”.
3. Because chapter 3 (Wagering) fully encompasses both breeds, the rescission of Chapter 13 (standardbred wagering) is ready to file.

# OHIO STATE RACING COMMISSION

## RESOLUTION 2023-10

**WHEREAS**, the Ohio State Racing Commission (“Commission”) has the authority under Revised Code 3769.03 to promulgate administrative rules;

**WHEREAS**, The Commission must comply with Ohio Rev. Code §121.95 by reducing regulatory restrictions;

**WHEREAS**, Chapters 3 and 13 were reviewed to remove duplicative and repetitive rules;

**WHEREAS**, Commission staff has sent out Chapter 3 and Chapter 13 to stakeholders for their review and comment. Commission staff has conducted meetings with the stakeholders to discuss these rules;

**WHEREAS**, The Commission desires no change to Chapter 3 Rules 3769-3-01, 3769-3-06 through 3769-3-10, 3769-3-12 through 3769-3-18, 3769-3-22, 3769-3-24 through 3769-3-27, 3769-3-30, 3769-3-36, 3769-3-38, and 3769-3-40;

**WHEREAS**, The Commission desires to amend Chapter 3 Rules 3769-3-02 through 3769-3-05, 3769-3-11, 3769-3-19 through 3769-3-21, 3769-3-23, 3769-3-28, 3769-3-32 through 3769-3-35, 3769-3-37, 3769-3-39, and 3769-3-99;

**WHEREAS**, The Commission desires to rescind Chapter 13;

**NOW, THEREFORE, BE IT RESOLVED**, by the Commission to have no change Chapter 3 Rules ; 3769-3-01, 3769-3-06 through 3769-3-10, 3769-3-12 through 3769-3-18, 3769-3-22, 3769-3-24 through 3769-3-27, 3769-3-30, 3769-3-36, 3769-3-38, and 3769-3-40 are APPROVED for filing with the Joint Committee on Agency Rule Review.

**NOW, THEREFORE, BE IT RESOLVED**, by the Commission to amend Chapter 3 Rules 3769-3-02 through 3769-3-05, 3769-3-11, 3769-3-19 through 3769-3-21, 3769-3-23, 3769-3-28, 3769-3-32 through 3769-3-35, 3769-3-37, 3769-3-39, and 3769-3-99 are APPROVED for filing with the Joint Committee on Agency Rule Review.

**NOW, THEREFORE, BE IT RESOLVED**, by the Commission to rescind Chapter 13 is APPROVED for filing with the Joint Committee on Agency Rule Review.
