Proper Discretion takes \$75,000 Mackey-Angenora Stakes

Proper Discretion didn't disappoint her backers, taking the \$75,000 Michael G. Mackey Memorial-Angenora Stakes on a bright and sunny afternoon, June 1 at JACK Thistledown in a romp for jockey Scott Spieth, trainer Jeff Radosevich and owner Ron Paolucci Racing, LLC.

Four Ohio-registered fillies and mares, 3-year-olds and up, traveled the six furlongs with the winner tripping the timer in a respectable 1:10.68.

With her bank account now at \$539,741, Proper Discretion notched her second straight victory as the 1-5 favorite. The multiple stakes-winning, 6-year-old daughter by Discreetly Mine-Prizes, by Prized was bred by Bruce Tallisman and bested 7-2 rival **True Cinder** (Gerardo Corrales), last year's winner of this stake, by nine lengths, with 7-1 **Ali Blue** (Ronald Allen, Jr) third and 8-1 **My Belle Michelle** (Christian Pilares) a distant fourth.

Proper Discretion has also captured the \$75,000 Scarlet & Gray Handicap twice (2017 & 2018), and the \$75,000 Petro Memorial at Thistledown twice (2018), the \$75,000 Diana Stakes (2017), and the \$75,000 First Lady Stakes (2016). She now has 15 wins, two seconds and seven thirds in 33 career starts, with 13 of those victories coming over the Thistledown dirt.
