## Minutes of the Ohio State Racing Commission Meeting held on June 23, 2021

- 1. The Ohio State Racing Commission ("Commission") held its' monthly meeting June 23, 2021, at Scioto Downs beginning at 10 am.
- 2. Commission Chairman Scott Borgemenke called the meeting to order. Commissioners Beth Hansen. Greg Simpson. and Thomas Winters were present. Commissioner Patmon was present by telephone.
- 3. Commissioner Simpson moved to approve the May 26, 2021, Commission meeting minutes. Commissioner Hansen seconded the motion. The motion was unanimously approved by roll call vote.
- 4. Executive Director Bill Crawford discussed the Executive Director's approvals. Commissioner Winters moved to ratify the Executive Director's approvals. Commissioner Simpson seconded the motion. The motion was unanimously approved by roll call vote.
- 5. Commission veterinarian, Dr. James Robertson, updated the Commission on horse fatalities in Ohio. Through June 15, 2021, there have been 21 fatalities for the thoroughbreds and 4 fatalities for the standardbreds.
- 6. Sherry White, Commission Fiscal Officer, gave her monthly financial report. May showed the Commission had a loss of \$25,000. Overall, the commission is down \$165.00 for the year to date.
